Re: Letter of Support for the Recognition of the Tuscarora Indians of Kahtenuaka Territories

Dear Representative Goodwin,

On behalf of The Waccamaw Indian People, please find this letter indicating our support of H.B. 600, and the petition by the Tuscarora Indians of Kahtenuaka Territories in their pursuit of official recognition by the State of North Carolina.

The Tuscarora Indians of Kahtenuaka Territories has a history of being one of the most powerful and formidable tribes in the region. Their history pre-dates the forming of both the State of North Carolina and the United States of America. The preceding historical document espouses a narrative that represents the relationship that existed and continues to this day. "Whereas the Tuscarora (sic) Indians have for more than a century been the firm and undeviating friends of the white people of this country insomuch that the State of North Carolina is disposed not only to render to them full and complete justice, but also to exercise towards them that spirit of generosity which their conduct has merited, . . ." (Grimes, 1911)

For tribal nations, particularly in the southeast, survival was, nevertheless, a matter of balancing between preservation of culture and forming relationships that would allow for a continuation of tribal community. The resilience and tenacity of the Tuscarora Indians of Kahtenuaka Territories should not only be recognized but also celebrated as an important part of the State of North Carolina's history, as they continue to demonstrate their longstanding contributions within Bertie County and beyond. We believe this can only be done through formal status of recognition by the State of North Carolina.

The Waccamaw Indian People, therefore, stand in full support of the petition by the Tuscarora Indians of Kahtenuaka Territories, and we pray for a favorable review.
